



# How to complain about poor quality of photovoltaic panels

How do I complain about a solar panel company?

You can submit a complaint to the solar panel company's BBB page. This does not fall under an official, legal complaint category, and it isn't a guarantee of follow-up action for your issue, but it gets your issue known. If you are lucky, the solar panel company might follow up with customers and give you a response.

Are customer complaints a problem in the solar industry?

Customer complaints against the country's residential rooftop solar industry have increased dramatically in recent years. One-star ratings on Solar Reviews increased more than 1,000% since 2018. Across the country, prosecutors are investigating high-pressure sales tactics and misleading financing arrangements.

Complaints against these two - among the largest providers - constituted nearly 56 percent of all the complaints consumers filed with the FTC about solar companies.

Should consumers be worried about shoddy Solar Contractors?

The report warned consumers about shoddy solar contractors and problematic leasing arrangements, highlighting, for example, a Maryland complaint regarding an 84-year-old man who had been induced to sign a 20-year lease for solar panels. Attorneys general are also taking steps to protect consumers from rooftop solar companies.

How many complaints are there about solar-panel salespeople?

Meanwhile, consumer complaints about solar-panel salespeople have skyrocketed in recent years. The FTC received 5,331 complaints containing the phrase "solar panels" between Jan. 1 and Sept. 19 of 2023, up 31% from the entire year of 2022 and up 746% since 2018, when it received just 630 complaints.

How many complaints did the FTC make about solar panels?

The FTC released a total of 1,219 complaints in response to CfA's Freedom of Information Act (FOIA) request for complaints pertaining to the sale or leasing of solar panels and their installation on the roofs of customers' homes from 2012 to the present.
